## juror

### Judy Morris, AWS, NWS

Judy Morris, earned B.S. and M.S. degrees in art education from Southern Oregon University in Ashland, Oregon. She taught art for thirty years at South Medford High School before retiring and becoming a professional watercolorist. In the last fifteen years she has been a popular juror and workshop teacher throughout the country and in Canada, Mexico, England, Switzerland, France, and Italy. Her paintings have received more than fifty national and regional awards and have been included in exhibitions throughout the country, most recently those sponsored by the American Watercolor Society, the National Watercolor Society, and the Transparent Watercolor Society of America.



In 2005 her painting, *Chinatown: San Francisco*, was given the Clara Stroud Memorial Award in the 138th international exhibition of the American Watercolor Society in New York City. She has had numerous feature articles in national publications including the Aug/Sept 2005 issues of *International Artist Magazine*. She is also a member of the West Coast Watercolor Society whose elected membership is limited to fifty artists living in the Pacific coast states. Her work has been included in more than a dozen recent watercolor books/publications including *Splash 4, 5, 7, 8 & 9*. She is the author of *Watercolor Basics: Light* published by North Light Books.

## application info:

Artists 18 years and older, residing in Arizona, Kansas, Oklahoma, Missouri, Nebraska, Colorado, New Mexico, & Texas are eligible to enter the KWS Great 8 Exhibition. Only original paintings in primarily aqueous medium (no water-based oils) on paper are acceptable. No computer-generated images accepted. Jury decision on all entries are final. All entries must **not** have been shown previously at a KWS competition. All entries submitted **must be available for purchase** at the time of the exhibition.

A 40 % commission is charged by The Wichita Center for the Arts on sales directly attributed to the exhibition. **Note: Each entrant will receive a copy of the Great 8 Exhibition catalog.** Prices must conform to Entry Card.

## presentation & fees:

All work should be framed, matted with white mats, and glazed with plexiglas.

Entry fees are non-refundable and payable to the Kansas Watercolor Society. Completed and signed entry card, slides, notification card, and **self-addressed stamped envelope** (for return of slides) must be received **no later than September 4, 2007.**

A maximum of (3) three 2" x 2" slides may be submitted for jurying. Slides must be clearly labeled with artist's name, title of work, image size, framed size, & 'Top' and numbered to correspond with entry form. Enclose a business sized, self-addressed stamped #10 envelope for return of rejected slides. Since preliminary selection will be made from slides, the juror and KWS stress the need for artists to accurately photograph their work. Paintings which do not match the slides in content and quality may be eliminated.



## shipping & liability:

Paintings will be shipped directly to The Wichita Center for the Arts, 9112 E. Central, Wichita, KS 67206.

The KWS and The Wichita Center for the Arts will not accept responsibility for loss or damage to work while in transit to and from The Wichita Center for the Arts. Artwork will be insured by The Wichita Center for the Arts while on center premises only.

Return shipping should be prepaid or a check enclosed for the correct amount, along with a return address shipping label. There will be no handling fee for shipped works.

Submission of an entry into the exhibition indicates agreement by the artist to the conditions in this prospectus.
